- A local public eating place or catering company, whose primary commercial function is to serve food to the general public
- Publicly-held, Cincinnati-based corporations will be considered on a case-by-case basis
- Menu will need to be returned with this application
- There is NO guaranteed vending space for past participants
- Must have been in operation for at least one (1) full year prior to the event taking place.
- The Events Committee has final authorization on who is chosen to take part in the event

 - **You may serve ONE "specialty" item at \$6.00 and all other items must be listed between \$1-\$5.00**

What's Next?

If accepted, you will be contacted and will need to turn in the completed contract and contract fee by **Thursday, April 19th 2018**. Along with the contract, you will also be given more details and information regarding your participation.

The contract fee will be \$700 and will include:

- 10' x 20' festival booth
- Two (2) eight foot banquet tables
- Four (4) chairs
- Two (2) 120V/20A electrical outlets
- Access to potable water, grease and ash waste barrels
- Tar paper flooring for booth
- Two (2) free vendor parking passes for vendor
- Advertising in the Red, White & Blue Ash brochure and social media outlets
- Roaming event security
- Hamilton County Board of Health Temporary License

*Additional items available for a nominal fee—refer to actual contract for these fees.

What You're Expected To Do If Chosen:

- Submit the Red White & Blue Ash Food Booth Vendor Contract, Contract Fee and all necessary paperwork by the stated deadline date, **Thursday, April 19th 2018**
- Complete all necessary paperwork by requested deadlines
- **Attend the Mandatory Restaurant Meeting (at least one principal or decision maker must attend)**
- Provide an electronic copy of your restaurant's color logo in either vector art EPS format or a high resolution JPEG or TIFF format (300 dpi) for marketing purposes
- Adhere to all guidelines and rules of Red, White & Blue Ash
